AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING TO EXECUTE THE SIXTH AMENDMENT TO THE AGREEMENT WITH TY LIN INTERNATIONAL FOR THE WEST MISSION BAY DRIVE BRIDGE OVER SAN DIEGO RIVER PROJECT.

WHEREAS, the proposed West Mission Bay Drive Bridge over San Diego River Project (Project) will replace the structurally deficient and functionally obsolete four-lane bridge with two three-lane bridges

WHEREAS, in 2000, the City advertised for professional engineering and environmental services for the Project; and

WHEREAS, the City Council approved the consultant agreement and subsequent amendments to the agreement with T.Y. Lin International for professional engineering and environmental services, which included, but was not limited to, feasibility studies, concept designs, bridge alternatives, environmental approval, and preparation of plans, specifications, and estimates (PS&E); and

WHEREAS, the proposed sixth amendment will supplement the approved professional services and include construction and environmental design support services for the construction phase of the project; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor or his designee is authorized to execute the Sixth Amendment to the Agreement with T.Y. Lin International for engineering services in CIP S-00871, West Mission Bay Drive Bridge Over San Diego River, in an amount not to exceed \$1,678,725, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. OO- 20883 together with any reasonably necessary modifications or amendments which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.
- 2. That the expenditure of an amount not to exceed \$1,678,725 from CIP S-00871, West Mission Bay Drive Bridge Over San Diego River, Fund 200385, Sea World Traffic Mitigation, is authorized for the purpose of executing one or more amendments to the agreement with TY Lin International.
- 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.
- 4. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

5.	That this ordinance shall take effect	and be in force on the thirtieth day from and
