AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF THE SEVENTH AMENDMENT TO THE AGREEMENT WITH DOKKEN ENGINEERING FOR THE STATE ROUTE 163 AND FRIARS ROAD INTERCHANGE PROJECT.

WHEREAS, the State Route 163 and Friars Road Interchange Project (Project) will provide for the modifications to the State Route 163 and Friars Road Interchange in order to optimize traffic circulation within the interchange area in State Route 163 and Friars Road Interchange; and

WHEREAS, the Project provides substantial benefits to traffic circulation, improving level-of-service on local streets and reducing congestion, is consistent with community planning documents and future phases of the project, improves business access within the project footprint and enhances the safety of pedestrians and bicyclists; and

WHEREAS, the Seventh Amendment to the Agreement with Dokken Engineering will provide for the preparation of additional feasibility studies, traffic analyses, the modification of the plans, specifications, and estimates, the preparation and submittal of the Recycled Water Project Review Application, and construction support services during the construction phase; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to execute a Seventh Amendment to the Agreement for design services with Dokken Engineering, Inc. for CIP S-00851, State Route 163 and Friars Road Interchange Project, in an amount not to exceed \$497,295.00.

That the Chief Financial Officer is authorized to expend an amount not to exceed 2.

\$497,295.00, of which \$400,000.00 from CIP S-00851, State Route 163 and Friars Road

Interchange Project, TransNet Extension 70% Cap, Fund 400169, TransNet and \$97,295.00 is

from CIP S-00851, SR-163 and Friars Road Interchange Project, Fund 400174, TransNet

Extension Regional Transportation Congestion Improvement Program (RTCIP) Fee, for the

purposes of executing this Seventh Amendment to the Agreement.

is authorized to transfer excess funds, if any, to the appropriate reserves.
