A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF A CONSULTING AGREEMENT WITH MICHAEL BAKER INTERNATIONAL, INC. FOR THE OFF/ON FHWA SYSTEM BRIDGE REHABILITATION PROJECT.

WHEREAS, the Bridge Preventive Maintenance Program (BPMP) is intended help local agencies to maintain the existing inventory of bridges structurally safe by correcting minor structural defects and deficiencies early in the bridges life, preventing future problems requiring costly rehabilitation, reconstruction, or replacement; and

WHEREAS, preliminary engineering activities and field reviews have identified BPMP eligible work for sixteen (16) bridges throughout the City of San Diego; and

WHEREAS, this action would authorize Michael Baker International, Inc. to provide engineering services to prepare Final Engineering Plans, Specifications, and Estimates (PSE) as stated in the scope of services for an amount not to exceed \$174,581; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute an agreement with Michael Baker International, Inc. for structural engineering design services in CIP A-IE.00001, Bridge Rehabilitation, in an amount not to exceed \$174,581.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend a total amount not to exceed \$174,581, from CIP A-IE.00001, Bridge Rehabilitation, of which \$44,608 is from Fund 200306, Prop 42 Replacement, (B15127, Off FHWA System Bridge Rehabilitation) and \$75,973 is from Fund 200306, Prop 42 Replacement, (B15128, On FHWA System Bridge Rehabilitation), and \$54,000 is from Fund 600001, State-Federal
