A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN JOAN MCCOLLOM AND THE CITY OF SAN DIEGO.

WHEREAS, Joan McCollom filed a claim (claim No. 12282) or about February 14, 2016, against the City of San Diego ["City"] alleging she was sustained property damage to her home when it was flooded with runoff and sediment during a severe weather event which destroyed personal property in her home and portions of her home and landscaping located at 6248 Cabaret Street. There is no lawsuit pending. This is a pre-litigation claim arising; and

WHEREAS, in Closed Session on October 18, 2016, the City Council, by the following votes: Yeas: 1; 2; 4; 5; 6; and 7 and Nays, None and Districts 3, 8 and 9 absent, approved the Settlement; and

WHEREAS, the City Council in closed session on October 18, 2016 authorized settlement of the pre-litigation Claim No. 12282 for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego that the Council is:

1. Authorizing the Mayor or his designee to pay the sum of \$103,279.77 from the Public Liability Fund #720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the January 5, 2016 property damage claim of Joan McCollom v. City of San Diego. (Risk Claim No. 12282). The City advanced Joan McCollum a total of \$50,000.00 so the final payment will reflect the remainder of her damages which equates to \$53,279.77.

- 2. Authorizing the Chief Financial Officer to appropriate and expend the total sum of \$53,279.77 from the Public Liability Fund #720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. Authorizing the Comptroller to issue a check for the outstanding balance of Fifty Three Thousand Two Hundred Seventy Nine Dollar and Seventy-Seven Cents (\$53,279.77) made payable to Joan McCollom.
