A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO SELECTING A COUNCILMEMBER TO SERVE AS CHAIR OF THE SCREENING COMMITTEE THAT WILL RECOMMEND PUBLIC MEMBER AUDIT COMMITTEE CANDIDATES TO THE CITY COUNCIL.

WHEREAS, on June 3, 2008, voters approved Proposition C which, in part, added new San Diego Charter (Charter) section 39.1 to address the responsibilities and composition of the City's Audit Committee; and

WHEREAS, the Audit Committee is comprised of two members of the City Council and three public members; and

WHEREAS, Charter section 39.1 further provides for a Screening Committee, charged with vetting the qualifications of public member Audit Committee candidates and recommending a pool of at least two candidates (for the public member position) for the City Council to consider for appointment; and

WHEREAS, the Screening Committee is to be comprised of a member of the City Council, the Chief Financial Officer, the Independent Budget Analyst, and two outside financial experts appointed by the other three members of the Screening Committee and confirmed by the City Council; and

WHEREAS, in order to implement the Audit Committee provisions of Charter section 39.1, the City Council must adopt a resolution appointing a member of the City Council to serve on the Screening Committee; and

WHEREAS, the Independent Budget Analyst recommends that the appointed

Councilmember serve as Chair, consistent with past practice of the Screening Committee; and

WHEREAS, the Council President has requested nominations from the City Council for

this appointment; and

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the

Mayor because this matter is exclusively within the purview of the City Council and not

affecting the administrative service of the City under the control of the Mayor; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that, pursuant to Charter

section 39.1, the appointment of Councilmember Georgette Gomez to serve as the Chair of the

Audit Committee Screening Committee is hereby confirmed.
