A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING MID-YEAR REVISIONS TO THE FISCAL YEAR 2017 BUDGET OF THE CITY OF SAN DIEGO.

WHEREAS, on June 14, 2016, the Mayor approved Resolution No. R-310506, approving the City's Fiscal Year 2017 Budget (2017 Budget); and

WHEREAS, on July 11, 2016, the City Council adopted Ordinance No. O-20669, entitled "An Ordinance Adopting the Annual Budget for the Fiscal Year 2017 and Appropriating the Necessary Money to Operate the City of San Diego for Fiscal Year 2017" (Appropriation Ordinance); and

WHEREAS, on January 30, 2017, the Fiscal Year 2017 Mid-Year Budget Monitoring Report, Report No. 17-010 (Report) was issued; and

WHEREAS, the Report projects a deficit of \$4.2 million relative to the adopted General Fund budget; and

WHEREAS, Section 15 of the Appropriation Ordinance authorizes the Chief Financial Officer to modify appropriations upon adopted City Council resolution, provided funding is available for such action and in accordance with finding source guidelines and applicable grant agreements; and

WHEREAS, the City Council desires to approve the proposed appropriation changes as described below and in accordance with the Report; NOW, THEREFORE;

BE IT RESOLVED, by the Council of the City of San Diego that the Chief Financial Officer is authorized to revise the Fiscal Year 2017 Budget, as detailed in Report No. 17-010, as follows:

- 1. Transfer up to \$5,900,000 in excess reserves from the Public Liability Reserve-Contingency Fund (720046) to the Public Liability Fund (720045).
- Increase expenditure and revenue appropriations in the Development Services
 Fund (700036) by up to \$2,000,000 for debt payments for the implementation of the Accela project.

BE IT FURTHER RESOLVED, by the City Council of the City of San Diego that the Mid-Year revisions to the 2017 Budget, as detailed in Report No. 17-010, are approved and the Chief Financial Officer is directed to amend and adjust the Fiscal Year 2017 Capital Improvement Program (CIP) budget appropriations as follows:

- Add CIP S-17009, 101 Ash Street Improvements, to the Capital Improvements
 Program; and
- Increase the Capital Improvements Program Budget in CIP S-17009, 101 Ash
 Street Improvements, and to appropriate and expend up to \$5,000,000 from Fund
 400866, 101 Ash Facility Improvements Fund.
