A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE AGREEMENT WITH ESTRADA LAND PLANNING FOR AS-NEEDED LANDSCAPE ARCHITECTURAL DESIGN SERVICES; AND TAKING RELATED ACTIONS.

WHEREAS, a consultant agreement with Estrada Land Planning will provide architectural services for various Capital Improvement Projects for an amount not to exceed \$3,000,000 with a maximum duration of five (5) years; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an As-Needed Architectural Services Agreement with Estrada Land Planning, to provide professional services in an amount not to exceed \$3,000,000, contingent upon the Chief Financial Officer first furnishing one or more certificates demonstrating that funds necessary for expenditure are, or will be, on deposit with the City Treasury, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. **RR-310948**.
- 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$3,000,000, over five (5) years for the purpose of funding the As-Needed Architectural Services Agreement with Estrada Land Planning, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
- 3. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 from Fund 200218, Underground Surcharge CIP, WBS No. A-ID.00001, Utilities

Undergrounding Program, for the purpose of executing this agreement and meeting minimum contract requirements.

4. That the Chief Financial Officer is authorized, upon advice from the administering department, to transfer excess funds, if any, to the appropriate reserves.
