(1) small business owner; (2) accounting, financial-lending, legal or economic backgrounds; and
(3) advocates of small business interests with governmental agencies; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment by the Mayor of the City of San Diego, to serve as a member of the Small Business Advisory Board, for a term expiring as indicated, is made and hereby confirmed:
