DATE OF FINAL PASSAGE FEB 22 2017

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING ANGLE PARKING ON  
WABASKA DRIVE BETWEEN WABASKA COURT AND  
VOLTAIRE STREET; AND TAKING RELATED ACTIONS.

WHEREAS, the City of San Diego plans to restripe Wabaska Drive from Nimitz Boulevard to Voltaire Street in order to make it consistent with its identification as a local street in the Peninsula Community Plan and accommodate the community's request for bikeways; and

WHEREAS, converting some of the existing parking on the east side of Wabaska Drive to angled parking will, along with the lane reduction and creation of bikeways, provide traffic calming and enhance overall safety for pedestrians, cyclists and motorists, and will maintain the required number of disabled spaces per the United States Access Board's Public Right-of-Way Accessibility Guidelines; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That in accordance with San Diego Municipal Code section 86.03 and California Vehicle Code section 22503, the installation of angle parking on the east side of Wabaska Drive from Wabaska Court to Voltaire Street is authorized.

2. That the Chief Financial Officer is authorized to expend funds not to exceed \$20,000 from CIP B-15181, Asphalt Overlay 1508-JOC 4, Fund 400859, LSE REV BND 2015A-CP, for the installation of angle parking, contingent upon the Chief Financial Officer

furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.


