WHEREAS, San Diego City Charter (Charter) section 39.1 establishes an Audit Committee comprised of two members of the San Diego City Council (City Council) and three public members; and

WHEREAS, Charter section 39.1 requires the City Council to appoint the public members of the Audit Committee from a pool of not less than two qualified candidates for each vacant position; and

WHEREAS, the position held by public member Ricardo Valdivia had an appointment date of July 29, 2013, and an expiration date of January 5, 2017; and

WHEREAS, the Independent Budget Analyst convened a screening committee, as required by Charter section 39.1, for purposes of filling this vacancy; and

WHEREAS, the screening committee has identified two candidates who are qualified to serve on the Audit Committee; and

WHEREAS, the City Council has interviewed the candidates and confirmed the appointment of one of these candidates to the Audit Committee for a four-year term; and

WHEREAS, under Charter section 280(a)(6) the City Council appointment of members of the Audit Committee is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following public member is appointed to the Audit Committee for a term ending as indicated:
