A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING CHANGE ORDER NO. 3 TO PUBLIC WORKS CONTRACT K-16-6725-EMR-3 FOR ADDITIONAL EMERGENCY MAINTENANCE OF THE STORM WATER SYSTEM IN THE HOTEL CIRCLE AREA.

WHEREAS, on November 16, 2015, the San Diego City Council (City Council) adopted San Diego Resolution R-310079, proclaiming the existence of a local state of emergency regarding anticipated El Niño weather conditions; and

WHEREAS, San Diego Municipal Code (Municipal Code) section 22.3108 provides that emergency public works contracts may be awarded without advertisement and competition when the public interest or necessity demands the immediate expenditure of public money to safeguard life, health, or property due to extraordinary fire, flood, storm, epidemic, or other disaster, provided that the Mayor immediately reports the emergency award to the City Council and describes the justifications therefore in writing, and the City Council subsequently ratifies the award by resolution of a two-thirds vote; and

WHEREAS, Arietta Construction, Inc., was engaged on March 1, 2016, to perform maintenance and cleaning within several concrete ditches, pipes, and headwalls at properties along Hotel Circle North, Hotel Circle South, and Camino del Rio (Project) which had experienced flooding and property damage during a storm in Jánuary 2016; and

WHEREAS, Public Works Contract K-16-6725-EMR-3, for Arietta Construction, Inc.'s maintenance and cleaning of the storm water system in the Hotel Circle area, was executed on June 14, 2016, pursuant to Municipal Code section 22.3108; and

WHEREAS, Public Works Contract K-16-6725-EMR-3 was ratified by the City Council through San Diego Resolution R-310646 on August 10, 2016; and

WHEREAS, it has been determined that the cost of the remaining work within a critical box culvert would exceed the amount authorized for the Project and recent successive storms have contributed to the increase in work; and

WHEREAS, approximately 1,800 feet of the culvert have been maintained, but additional funds are necessary to complete the remaining 1,300 feet of the culvert, and any additional necessary maintenance caused by the storms in recent months; and

WHEREAS, the City of San Diego (City) Transportation and Storm Water Department requests the City Council approve Change Order No. 3 as an additional expenditure of \$1,250,000 for the completion of the work authorized under Public Works Contract K-16-6725-EMR-3, resulting in a total cumulative expenditure of \$2,500,000 under the contract; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute Change Order No. 3 to Public Works Contract K-16-6725-EMR-3 with Arietta Construction, Inc., for an amount not to exceed \$1,250,000.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an additional amount not to exceed \$1,250,000 for Change Order No. 3 to Public Works Contract K-16-6725-EMR-3, contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
