DATE OF FINAL PASSAGE MAR 15 2017

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CHANGING THE DATE AND TIME FOR A PUBLIC
HEARING RELATING TO ESTABLISHMENT OF THE OTAY MESA
ENHANCED INFRASTRUCTURE FINANCING DISTRICT.

WHEREAS, the California Legislature enacted California Government Code (Code) sections 53398.50 through 53398.88 (EIFD Law) authorizing cities to form enhanced infrastructure financing districts; and

WHEREAS, the Council adopted Resolution R-310937, effective as of February 13, 2017, stating its intention to form the Otay Mesa Enhanced Infrastructure Financing District (Otay Mesa EIFD) and setting the time and place for a public hearing required by the EIFD Law on June 26, 2017, at 10:00 a.m. Pacific Time, in the Council Chambers located at 202 C Street, 12th Floor, San Diego, subject to potential continuance as determined to be necessary in the discretion of the Otay Mesa Enhanced Infrastructure Financing District Public Financing Authority (Authority), in accordance with Code section 53398.67 and other applicable law; and


WHEREAS, after reviewing the timeline for formation of the Otay Mesa EIFD, City staff has determined that the June 26, 2017, public hearing date is not possible given the significant milestones regarding noticing, appointment, and confirmation of Authority members, public input and outreach, and the final approval of an Infrastructure Financing Plan; and

WHEREAS, the Council desires to change the date of the public hearing set in Resolution R-310937; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. Time and Place for Public Hearing. The Council changes the date of the public hearing set on June 26, 2017, at 10:00 a.m. Pacific Time in Resolution R-310937, to July 24, 2017, at 10:00 a.m. Pacific Time, or as soon thereafter as the matter may be heard, in the Council Chambers located at 202 C Street, 12th Floor, San Diego, subject to potential continuance as determined to be necessary in the discretion of the Authority, in accordance with Code section 53398.67 and other applicable law.
2. Transmittal of Resolution. The City Clerk is authorized and directed on behalf of the Council to send a copy of this Resolution to the Authority, each owner of land within the Otay Mesa EIFD, and each affected taxing entity of the Otay Mesa EIFD. City staff shall provide the City Clerk with a mailing list of owners of land within the Otay Mesa EIFD from property owner of record data maintained by the County of San Diego Assessor.
3. Effect. After adoption of this Resolution, Resolution R-310937 shall remain in full force and effect, as expressly modified by this Resolution.
