A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$5,000 TO THE CLAIREMONT HILLS KIWANIS FOUNDATION FOR THE CLAIREMONT DAY AT THE BAY EVENT, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Clairemont Hills Kiwanis Foundation has requested funding for the Clairemont Day at the Bay event; and

WHEREAS, the requested funding will be used to cover expenses related to renting event and party equipment; and

WHEREAS, the Clairemont Day at the Bay event will benefit will benefit the public by connecting schools with the community and giving families access to intonation about services available to them; and; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, the City Council approved an allocation of \$2,500 recommended by Council District 6 for Day at the Bay with R-2017-228 on November 15, 2016; and now Council District 2

recommends an additional allocation of \$2,500 to the Clairemont Hills Kiwanis Foundation for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2017 City Council Allocations Agreement between the City of San Diego and the Clairemont Hills Kiwanis Foundation (Agreement) in an amount not to exceed \$5,000 for the project described in this resolution and R-2017-228, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-310975.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,500 from Council District 2: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1102110002 is in addition to the \$2,500 from Council District 6: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1106110006, approved by R-2017-228, for a total of \$5,000, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
