A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$7,500 TO VIA INTERNATIONAL INC., FOR THE CHICANO PARK DAY 2017, PURSUANT TO COUNCIL POLICY 100-23, "CITY COUNCIL FUNDING FOR ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCY TAX ALLOCATION."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, entitled "City Council Funding of Arts, Culture and Community Festivals with Transient Occupancy Tax Allocation" on August 13, 2012, by Resolution R-307625; and

WHEREAS, among other things, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to, San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, Via International Inc., has requested funding for the Chicano Park Day 2017; and

WHEREAS, the requested funding will be used for City permitting and public safety costs; and

WHEREAS, Via International Inc.'s request for funding for Chicano Park Day 2017 will benefit the community by continuing with the annual tradition of the Chicano Park Day celebration, a family friendly event open to the public; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-23; and

WHEREAS, Council District 8 recommends an allocation of \$7,500 to Via International Inc. for the Chicano Park Day 2017 as set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, an agreement between the City of San Diego and Via International Inc. (Agreement) in an amount not to exceed \$7,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-310978.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$7,500 from CD 8: Fund No. 200205, Cost Center No. 1414111219 to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the recommended funding for the project described herein is made to provide access in culture and the arts for residents of, and visitors to, |

San Diego, and to enrich the lives of the people of San Diego and build healthy, vital neighborhoods.
