CALIFORNIA DEPARTMENT OF TRANSPORTATION'S  
SYSTEMIC SAFETY ANALYSIS REPORT PROGRAM  
(SSARP); AND TAKING RELATED ACTIONS.


BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or designee, is authorized and empowered for and on behalf of the City to accept and expend grant funds in an amount not to exceed \$247,500 from the California Department of Transportation's (Caltrans) Systemic Safety Analysis Report Program (SSARP) for the purpose of conducting a citywide collision analysis pursuant to the City's Vision Zero initiative (Project).

BE IT FURTHER RESOLVED, that the Chief Financial Officer, is authorized to accept, appropriate and expend SSARP funds in the amount not to exceed \$247,500 from Systemic Safety Analysis Report Program (SSARP), Fund 600001, State Grant Fund, contingent upon the receipt of a fully executed grant agreement.

BE IT FURTHER RESOLVED, that the Chief Financial Officer, is authorized to appropriate and expend an amount not to exceed \$27,500 from Fund 100000, General Fund,

Business Area 2116, Transportation & Storm Water, for the purpose of funding grant match requirements, contingent upon the receipt of a fully executed grant agreement.
