DATE OF FINAL PASSAGE MAR 15 2017

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE INSTALLATION OF
ANGLE PARKING ON THE EAST AND WEST SIDES OF
22ND STREET BETWEEN E STREET AND F STREET
AVENUE.

WHEREAS, the Transportation Engineering Operations Division of the Transportation
and Storm Water Department has received a request to convert parallel parking to angle parking
on the east and west sides of 22nd Street between E Street and F Street; and

WHEREAS, the Transportation Engineering Operations Division has calculated that an
increase of six parking spaces will be achieved by the installation of angle parking at this
location; and


WHEREAS, two of the six new spaces will be converted to disable parking spaces,
located near the southeast corner of 22nd Street and E Street, and the northwest corner of 22nd
Street and F Street; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that in accordance with San
Diego Municipal Code section 86.0104 and California Vehicle Code section 22503, the
installation of angle parking on the on the east and west sides of 22nd Street between E Street
and F Street is authorized.

BE IT FURTHER RESOLVED, that the installation of necessary signs and markings for
such angle parking is authorized, and the regulations shall become effective on installation of
signs.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$4,800 from General Fund 100000, Transportation & Storm Water – Street Division’s (211611) operating budget for the installation of angle parking on the east and west sides of 22nd Street between E Street and F Street.
