BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$4,800 from General Fund 100000, Transportation & Storm Water – Street Division's (211611) operating budget for the installation of angle parking on the east and west sides of 22nd Street between E Street and F Street.
