DATE OF FINAL PASSAGE MAR 14 2017

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO RATIFYING THE LOCAL EMERGENCY
PROCLAIMED BY THE DIRECTOR OF EMERGENCY
SERVICES RELATING TO RECENT RAIN STORMS.

WHEREAS, Municipal Code section 51.0106(a)(1) empowers the Director of Emergency Services to proclaim the existence of a Local Emergency when the City is affected, or likely to be affected, by a public calamity and the City Council is not in session, subject to ratification by the City Council within seven days; and

WHEREAS, such Proclamation entitles the Director of Emergency Services, and the emergency organization of this City, to all the power, functions, and duties prescribed by state law, the San Diego Charter, the San Diego Municipal Code, ordinances, and resolutions of this jurisdiction during the existence of said Local Emergency; and

WHEREAS, conditions of extreme peril to the safety of persons and property did arise within the City caused by a series of storms commencing on or about February 26, 2017; and


WHEREAS, the Director of Emergency Services did issue a Proclamation of Local Emergency within the City on the March 8, 2017; and

WHEREAS, that Proclamation designated the Mayor as the authorized representative of the City for the purpose of receipt, processing and coordination of all inquiries and requirements necessary to obtain available state and federal assistance; and

WHEREAS, the City Council does hereby find that the aforesaid conditions of extreme peril did warrant and necessitate the Proclamation of Local Emergency; NOW, THEREFORE,

BE IT RESOLVED AND PROCLAIMED, by the City Council of the City of San Diego, that the Proclamation of Local Emergency issued by the Director of Emergency Services on March 8, 2017 is hereby ratified and confirmed.
