A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO SUPPORTING THE FY16 CONDITION
ASSESSMENT REPORT RECOMMENDED SERVICE LEVELS
FOR CITY-OCCUPIED AND LEASED GENERAL FUND
FACILITIES.

WHEREAS, the Council of the City of San Diego (Council), published a report drafted by the Public Works Department, Report to Council No. 16-105 (Nov. 29, 2016), that summarized the condition assessment findings of 133 leased general fund facilities and 560 city-occupied general fund facilities that were assessed in FY14 through FY16. In addition, in this report (SLA1) staff recommended a goal (SLA2) Facilities Condition Index (FCI) score of 15 for public and semi-public general fund facilities, a goal FCI score of 20 for office, work yard and operations general fund facilities, and a goal FCI score of 20 for commercial, residential leased general fund facilities; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City supports the recommended goal FCI score of 15 for public and semi-public general fund facilities.
2. That the City supports the recommended goal FCI score of 20 for office, work yard and operations general fund facilities.

3. That the City supports the recommended goal FCI score of 20 for commercial, residential leased general fund facilities.


