A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING JOB ORDER CONTRACT (JOC)
SP-15 STREET PAVING #2 NORTH OF I-8 WITH ATP
GENERAL ENGINEERING CONTRACTORS VIA CHANGE
ORDER NO. 1.

WHEREAS, on May 20, 2015, the City entered into two Paving Job Order Contracts: one with ATP General Engineering Contractors for projects north of I-8 for an amount of \$20,000,000, and the other with TC Construction Company for projects south of I-8 for an amount of \$20,000,000; and

WHEREAS, to date, the City has issued four task orders with ATP for a cumulative amount of \$18,869,760 utilizing most of available capacity under their contract and has issued three task orders with TC Construction for a cumulative amount of \$10,877,218, both contracts due to expire on May 20, 2017; and

WHEREAS, TC Construction has declined to perform any more paving work for the City under this current contract, but additional paving is needed to meet annual goals; and

WHEREAS, provisions were included in each of the paving contracts to allow the other paving contractor to perform any work declined by the primary contractor in such a situation; and

WHEREAS, ATP is available to perform additional paving work and this action will increase the capacity of ATP's contract in order to perform additional work south of I-8, which will be authorized as additional task orders under the revised contract; and


WHEREAS, this change order will increase the capacity of the ATP's contract from \$20,000,000 to \$30,000,000 and will extend the duration of the contract by 103 calendar days,

which will provide for the needed paving work until the next phase of paving contracts can be issued in the fall of this year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute Change Order No. 1 to Job Order Contract (JOC) SP 15 Street Paving #2 (North of I-8) with ATP General Engineering Contractors in an amount not to exceed \$10,000,000 contingent upon the City Comptroller first providing one or more certificates that funding is available with the City Treasurer.
