
A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING ADVERTISEMENT, AWARD AND EXECUTION OF A CONSTRUCTION CONTRACT FOR THE SLURRY SEAL GROUP 1703 PROJECT; AND TAKING RELATED ACTIONS.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to advertise and execute, for and on behalf of the City, a construction contract with the lowest responsible and reliable bidder, in an amount not to exceed \$5,000,000, for the Slurry Seal Group 1703 project.

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000,000 from Fund 200306, Prop 42 Replacement fund, Transportation & Storm Water Department - Street Division, for the purpose of funding Slurry Seal Group 1703 construction contract, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasury.
