A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING AN AMENDMENT TO THE GENERAL PLAN AND THE OTAY MESA COMMUNITY PLAN FOR THE CENTRAL VILLAGE SPECIFIC PLAN – PROJECT NO. 408329.

WHEREAS, on April 4, 2017, the City Council of the City of San Diego held a public hearing for the purpose of considering an amendment to the General Plan and the Otay Mesa Community Plan to adopt the Central Village Specific Plan designating uses, development intensity, design guidelines and supplemental regulations to the Central Village area; and

WHEREAS, the Planning Commission of the City of San Diego found the proposed amendment consistent with the General Plan; and

WHEREAS, the Council of the City of San Diego has considered all maps, exhibits, and written documents contained in the file for this project on record in the City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,
