A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE REVISED BURGLARY AND PANIC ALARM SYSTEMS FEES AND AMENDING THE CITY OF SAN DIEGO RATEBOOK.

WHEREAS, the San Diego Police Department (Police Department) is granted the authority to issue permits, conduct regular inspections, and enforce regulations on a variety of businesses, occupations and activities collectively referred to as Police Regulated Businesses; and

WHEREAS, the City of San Diego (City) currently charges a fee to regulate the use and operation of burglary and panic alarm systems within the City; and

WHEREAS, the City wishes to make changes to the permit fees associated with regulation of burglary and panic alarm systems; and

WHEREAS, the City wishes to establish fines and penalty fees associated with the enforcement of burglary and panic alarm systems; and

WHEREAS, California Proposition 26, which passed in November 2010, amended articles XIII A and XIII C of the California Constitution and created a new definition of a "tax" that required two-thirds voter approval of any "tax" imposed by a local government unless the fee was a reasonable regulatory cost or a penalty or fine imposed to gain compliance of local regulations; and

WHEREAS, it is the policy of the City to establish fees to recover the costs of providing services in accordance with the City of San Diego Administrative Regulation 95.25; and

WHEREAS, Administrative Regulation 95.25 encourages transferring specific fee schedules listed in the San Diego Municipal Code (Municipal Code) and Council Resolutions to the standardized Ratebook maintained by the San Diego City Clerk; and

WHEREAS, the City has an adopted User Fee Policy dated March 10, 2009 (Council Policy 100-05); and

WHEREAS, the Police Department conducted a full evaluation of the costs and revenues associated with providing alarm system permit services; and

WHEREAS, permissible regulatory costs include issuing permits, performing investigations, inspections, audits, administrative enforcement, and adjudication; and

WHEREAS, the City charges a cost recovery regulatory fee for the issuance of alarm system permits and for the administration of the false alarm tracking and management system software; and

WHEREAS, the regulatory cost of issuing a permit is borne by the permittee and is codified in Municipal Code sections 33.0307 and 33.0308; and

WHEREAS, the City desires to have a Fee Schedule that supports compliance after the first false alarm and continues to motivate alarm users to prevent false alarms before their alarm system permit is revoked; and

WHEREAS, to gain compliance from alarm system users, the City wants to charge penalties and fines for violations of the regulations as soon as they occur; and

WHEREAS, the Police Department conducted a survey of penalty fees and fines imposed by other jurisdictions for operating an alarm system without a permit and for generating false alarms; and WHEREAS, a penalty fee will be assessed against alarm users who fail to maintain a permit and generate a police call for service, and is codified in Municipal Code section 33.3712; and

WHEREAS, a fine will be assessed against alarm users who generate a false alarm and is codified in Municipal Code sections 33.3712 and 33.3717; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the fees related to alarm system permit fees, fines, and penalty fees, reflected in the summary table, as ATTACHMENT A1, are hereby approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to amend the fee schedule on file in the Clerk's Office to include the permit fees, fines and penalty fees as reflected in ATTACHMENT A1.

BE IT FURTHER RESOLVED, that the permit fees, fines and penalty fees as reflected in ATTACHMENT A1 are effective contingent upon Ordinance No. O-_________amending the Municipal Code relating to burglary and panic alarm systems becoming effective.
