A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING CHANGE ORDER NO. 2  
FOR SEWER AND WATER GROUP 767A.

WHEREAS, Sewer and Water Group 767A [Project] is located in the Normal Heights community, and it includes replace-in-place of about 11,612 Linear Feet (LF) and the rehabilitation of 809 LF of existing Vitrified Clay (VC) sewer mains with Polyvinyl Chloride Pipe (PVC); and

WHEREAS, on August 20, 2015, the City and Ortiz Corporation entered into a contract for the construction of the Project; and


WHEREAS, during construction of the sewer main it was discovered that the water main which runs along the same alignment was deteriorating, and it was determined that it would be more economical and would minimize the impacts to the community to replace the existing water main as part of the current sewer construction project; and

WHEREAS, Change Order No. 2 is for installation of 7,200 LF of a new PVC 8-Inch water main for an amount not to exceed \$2,239,074.44; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor, or his designee is authorized to execute Change Order No. 2, on file with the Office of the City Clerk as Document No. RR- 311022 issued in connection with the contract between the City of San Diego and Ortiz Corporation to increase the contract price to an amount not to exceed \$2,239,074.44, and an extension of 210 working days for a total of 452 working days.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an additional amount not to exceed \$2,239,074.44 from CIP A-KB.00003, Main Replacements (B-17049, Sewer & Water Group 767A (W)), Fund 700010, Water Utility CIP for construction of the Project.


