A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE COUNCIL POLICY NO._____TITLED NAMING OF CITY ASSETS

WHEREAS, on May 19, 2011, the City Attorney's Office issued a Memorandum of Law [City Att'y MOL No. 2011-4 (May 19, 2011)] titled "Corporate Sponsorship of Public Property and Naming Rights"; and

WHEREAS, the City does not have a comprehensive citywide policy addressing the naming or renaming of its buildings and other assets; and

WHEREAS, staff proposes the City Council adopt a Council Policy governing naming and renaming rights to allow the City to point to an established policy to guide its naming and renaming decisions according to the City's objectives and to ensure naming opportunities represent City values; and

WHEREAS, as defined in the proposed policy, City Assets subject to the Council Policy include tangible or intangible items of value that are owned or created by the City, including but not limited to both City facilities and leaseholds that do not exceed 35 years and/or that confer ownership rights by agreement; and

WHEREAS, the Council Policy outlines the criteria, conditions, and procedures that govern naming and renaming of City Assets in order to maintain their integrity, encourage philanthropic giving while acknowledging public investments or support, and to safeguard against unwanted commercialization of City Assets; and

WHEREAS, the Council Policy would create consistency, transparency and streamlining of the process of naming or renaming City Assets citywide, while consolidating current practices contained in a number of department naming and renaming policies and procedures; and

WHEREAS, the Budget and Government Efficiency Committee reviewed the proposed Council Policy on naming and renaming City Assets at its March 8, 2017 meeting and voted unanimously to forwarded it to the full Council with a recommendation to adopt the proposed Council Policy; and NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council Policy No. _____ titled "Naming of City Assets" is approved and adopted.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to update the Council Policy Manual to reflect the addition of this Council Policy.
