WHEREAS, the City of San Diego Debt Policy (Debt Policy) was initially adopted by the City Council on November 6, 2007; and

WHEREAS, the Debt Policy is reviewed biennially and a report is prepared detailing developments in the financial markets, the City's anticipated financing calendar, and the debt profile of the City and certain of its related entities; and


WHEREAS, the revised Debt Policy (Revised Debt Policy), showing changes from the policy last approved in 2015, was presented to the Budget and Finance Committee (Committee), along with the annual report, on March 8, 2017, and the Committee voted to forward the Revised Debt Policy to the full City Council for consideration and approval; and

WHEREAS, the Revised Debt Policy, on file with the City Clerk as Document No. RR- 311057, and the annual Debt Policy Report (Debt Policy Report), Report No. 17-018, have been presented to the City Council; NOW, THEREFORE,

BE IT RESOLVED, that the Revised Debt Policy is hereby adopted.


