DATE OF FINAL PASSAGE MAY 05 2017

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF A FIRST AMENDMENT TO THE COOPERATIVE PROCUREMENT CONTRACT WITH WAXIE'S ENTERPRISES, INC. FOR SUPPLIES FOR MAINTENANCE, REPAIR, AND OPERATIONS.

WHEREAS, the City may enter into a cooperative procurement contract for supplies for maintenance, repair, and operations without competitive bidding pursuant to San Diego Municipal Code section 22.3208; and

WHEREAS, purchasing chemical-related janitorial and sanitation supplies for the City through a national cooperative procurement contract is to the City's economic advantage and in the City's best interests; and

WHEREAS, on June 30, 2016, the City entered into a cooperative procurement contract with Waxie's Enterprises, Inc., dba Waxie Sanitary Supply (Waxie), which was procured through the National Cooperative Purchasing Alliance, pursuant to the terms and conditions of Contract No. 08-16 (Contract); and

WHEREAS, the processes used to determine the vendors for the cooperative procurement contract with Waxie substantially comply with the City's procurement process, including public advertisement for sealed bids and awards determined on the basis of best value; and

WHEREAS, the parties now desire to enter into a First Amendment to the Contract to increase the not to exceed amount; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, the First Amendment to the Contract with Waxie's Enterprises, Inc. dba Waxie Sanitary


Supply, for supplies for Maintenance, Repair, and Operations, through the National Cooperative Purchasing Alliance, pursuant to the terms and conditions of Contract No. 08-16, for the purpose of increasing the not-to-exceed amount during the term of the Contract to \$9,600,000, and otherwise modifying the Contract pursuant to the terms and conditions contained in the First Amendment to the Contract on file in the Office of the City Clerk as Document No. RR-
311060.

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$9,600,000 over the term of the Contract with Waxie's Enterprises, Inc. dba Waxie Sanitary Supply, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. That the Mayor or his designee is authorized to negotiate and execute any documents that may be necessary to register with, and purchase supplies from, the vendor identified herein.
