DATE OF FINAL PASSAGE MAY 25 2017

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING AN AMENDMENT TO THE GENERAL PLAN AND CHANGING THE DESIGNATION SITE IN SUBAREA 37 OF THE UNIVERSITY COMMUNITY PLAN FROM SCIENTIFIC RESEARCH TO OPEN SPACE FOR TOWNE CENTRE DRIVE – PROJECT NO. 291342.

WHEREAS, on April 25, 2017, the City Council of the City of San Diego held a public hearing for the purpose of considering an amendment to the General Plan and to change the designation of a site in Subarea 37 of the University Community Plan from Scientific Research to Open Space; and

WHEREAS, Kilroy Realty, L.P., a Delaware Limited Partnership, requested an amendment to the General Plan and the University Community Plan to facilitate the Towne Centre Drive project located at 9455 Towne Centre Drive, and legally described as Parcel 3 of Parcel Map No. 16265, according to Map thereof No. 16255, filed October 18, 1990, in the University Community Plan area, in the IP-1-1 zone, City of San Diego, County of San Diego, State of California; and

WHEREAS, the Planning Commission of the City of San Diego recommended approval of the proposed amendments to the General Plan and the University Community Plan; and

WHEREAS, the Council of the City of San Diego has considered all maps, exhibits, and written documents contained in the file for this project on record in the City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that it adopts the amendment to the General Plan.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that it adopts the amendment to the University Community Plan, a copy of which is on file in the office of the City Clerk as Document No. RR- 311075.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that this resolution shall be effective 80 days after the filing of the Notice of Determination for Mitigated Negative Declaration No. 291342.

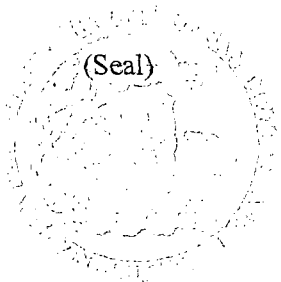
