A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING COUNCILMEMBER
APPOINTMENTS TO THE TEMPORARY SPECIAL ISSUES
COUNCIL COMMITTEE NAMED THE SELECT COUNCIL
COMMITTEE ON HOMELESSNESS.

WHEREAS, temporary Rule 6.11.3 of the Rules of the Council in the San Diego
Municipal Code, approved by the Council of the City of San Diego, has established the
temporary Special Issues Council Committee named the Select Council Committee on
Homelessness; and

WHEREAS, temporary Rule 6.11.3 provides that the Council President shall nominate
the committee Chair, Vice Chair, and committee members, subject to confirmation by a majority
vote of the City Council; and


WHEREAS, Council President Myrtle Cole has submitted nominations for those who are
to serve on the Select Council Committee on Homelessness for calendar year 2017 or until

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the
Mayor because this matter is exclusively within the purview of the City Council and not
affecting the administrative service of the City under the control of the Mayor; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to the
San Diego Municipal Code, the following appointments by the Council President, to serve as
Chair, Vice Chair, and committee members of the temporary Special Issues Council Committee
named the Select Council Committee on Homelessness, to serve for the 2017 calendar year or

until a successor is duly appointed and confirmed, are hereby confirmed: Councilmember
Chris Ward (Chair), Councilmember Georgette Gomez (Vice Chair), Councilmember Lorie Zapf
and Councilmember Chris Cate.

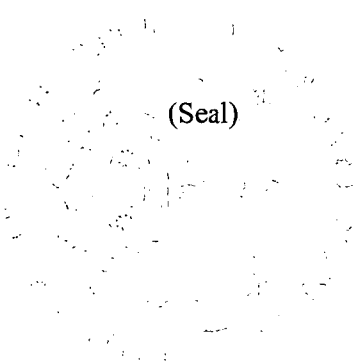
