WHEREAS, the City desires to create a perpetual City of San Diego Water Conservation Rebate Program, which will allow the City to implement new water conservation rebates and services as opportunities arise; and

WHEREAS, the purpose of establishing this program is to give the City the authority and flexibility to offer rebates and discounts for water efficient appliances, including new and innovative products and services, offer promotional items at water conservation events, conferences, community meetings, and provide other products and services that encourage, educate, or promote water conservation; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the City of San Diego Water Conservation Rebate Program is hereby established, to be administered by the City Manager through the Public Utilities Department, for purposes of offering rebates and discounts for water efficient appliances, including new and innovative products and services, offering promotional items at water conservation events, conferences, community meetings, and providing other products and services that encourage, educate, or promote water conservation.

BE IT FURTHER RESOLVED, that funding for the City of San Diego Water

Conservation Rebate Program will be provided by the water and wastewater enterprise funds,
based on funding approved in the annual City budget each fiscal year, and provided that the

Chief Financial Officer first certifies that sufficient funds are or will be available in the City

Treasury.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept and expend funds from other federal, state, and local agencies or sources to advance the purposes of the City of San Diego Water Conservation Rebate Program.
