DATE OF FINAL PASSAGE MAY 25 2017

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO AUTHORIZE AN INCREASE IN FUNDING
FOR THE REGENTS ROAD WIDENING GENESEE AVENUE
TO EXECUTIVE DRIVE IMPROVEMENT PROJECT.

WHEREAS, the Regents Road Widening Project will expand Regents Road to a
modified Four-Lane Street from Genesee Avenue to Executive Drive; and

WHEREAS, the project is approximately 50% complete and requires an additional
\$750,000 in funding to complete, so this action will allocate the necessary funding; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial
Officer is authorized to increase the Fiscal Year 2017 Capital Improvement Budget in S-00881,
Regents Road Widening Project and is authorized to appropriate and expend an amount not to
exceed \$750,000 in Fund 400849, North University City DIF contingent upon the Chief
Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or
will be, on deposit with the City Treasurer.


