ASH PROJECT WATER SUPPLY ASSESSMENT.


WHEREAS, Civic San Diego (CivicSD) requested that the City of San Diego Public Utilities Department (PUD) prepare a Water Supply Assessment (WSA), on file with the Office of the San Diego City Clerk as Document No. RR- 311120, as part of the environmental review for the 499 West Ash Project (Project); and

WHEREAS, upon review, the PUD determined that the Project met the threshold requirements defined by California Water Code section 10912(a)(7) and required the completion of a WSA in conformance with SB 610; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to adopt the Water Supply Assessment for the 499 West Ash Project to fulfill the requirements of California Water Code sections 10910, *et seq.*


