A RESOLUTION OF THE COUNCIL OF THE CITY  
OF SAN DIEGO CONFIRMING APPOINTMENTS  
TO THE COMMUNITY FOREST ADVISORY BOARD

WHEREAS, the Community Forest Advisory Board (formerly the Tree Advisory Board) is established in San Diego Municipal Code section 26.0501 to advise the Mayor, City Council and City Manager on policy issues relating to urban forestry; and

WHEREAS, the Municipal Code provides that the Board consists of fifteen members appointed by the Mayor and confirmed by the City Council; and

WHEREAS, members serve three-year terms and each member serves until a successor is appointed and confirmed; and


WHEREAS, members shall be appointed so that the terms of not more than five members shall expire in any year; NOW, THEREFORE,


