DATE OF FINAL PASSAGE JUN 07 2017

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE APPROVAL OF AN AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND THE POINT LOMA ASSOCIATION FOR THE CHATSWORTH/VOLTAIRE MEDIAN IMPROVEMENT, IS CATEGORICALLY EXEMPT FROM CEQA PURSUANT TO SECTION 15301 OF THE STATE CEQA GUIDELINES.

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, Section 15000 et seq.) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of Projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the City of San Diego desires to authorize the Agreement with Point Loma Association, on file in the Office of the City Clerk as Document No. RR- 311163, for the Chatsworth/Voltaire Median Improvements (Project); and

WHEREAS, the Chatsworth/Voltaire Median Improvements is categorically exempt from CEQA pursuant to CEQA Guidelines section 15301 (Existing Facilities) in that the Project entails the operation, maintenance, or repair of existing public or private structures, with negligible or no expansion of use, and Section 15304, as it consists of minor public or private


alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees except for forestry or agricultural purposes; and

WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of the Project; and

WHEREAS, the City Council held a duly noticed public meeting and considered the written record for the Project as well as public comment; NOW, THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego, using its independent judgment, has considered the written record and public comment concerning City staff's request to approve the Project, and determines that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines sections 15301 and 15304, and that an exception to the exemption as set forth in CEQA Guidelines section 15300.2 does not apply.
