A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AGREEMENT WITH NIXON PEABODY, LLP TO PROVIDE OUTSIDE COUNSEL OPINIONS FOR STATE REVOLVING LOAN FUND PROJECT APPLICATIONS; AND ASSOCIATED ACTIONS.

 1. to provide the San Diego Public Utilities Department with as-needed outside counsel opinion letters supporting the issuance of SRF loan applications in an amount not to exceed \$250,000, for an Agreement duration of five (5) years, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be on deposit with the City Treasurer.

That the Chief Financial Officer is authorized to expend a cumulative amount not to exceed \$250,000 in total, for the purposes of the Agreement, from the Water Utility Operating Fund 700011, the Metro Sewer Utility Fund 700001, and the Muni Sewer Revenue Fund 700000, over the term of the Agreement, for the purpose of retaining Nixon Peabody LLP as

outside counsel for SRF loan opinions, contingent upon adoption of the Annual Appropriation

Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer

furnishing one or more certificates certifying that the funds necessary for expenditure are, or will

be, on deposit with the City Treasurer.
