WHEREAS, the City Clerk serves as the election official for the City of San Diego; and

WHEREAS, the City of San Diego City Clerk Administrative Guidelines (the Guidelines) are referenced in the San Diego Municipal Code and include requirements applicable to municipal political candidates' designations of title on ballot materials, and to the form and formatting requirements for referendum, initiative, and recall petitions; and

WHEREAS, certain form and formatting requirements previously referenced in the San Diego Municipal Code state that they are detailed in the Guidelines, providing the City Clerk's Office with an easier way to keep the requirements updated and to reflect best practices; and

WHEREAS, the Guidelines are brought back to the City Council periodically for review and approval if amendments are proposed; and

WHEREAS, the City Clerk now seeks to add to the Guidelines new Section 406, "Consideration of Electronic Publication of Ballot Language," and Section 407, "Electronic Format Specifications," which relate to electronic publication of certain ballot materials; and

WHEREAS, the updates address when the City Clerk will inform the Council about whether the City Clerk is considering electronic publication of certain ballot materials, and will

specify the type of electronic format a proponent must use to submit the text of a qualified ballot

measure petition to the City Clerk; and
