A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AS-NEEDED AGREEMENT WITH RAFTELIS FINANCIAL CONSULTANTS, INC. FOR VARIOUS WATER, WASTEWATER, AND RECYCLED WATER SERVICES INCLUDING COST OF SERVICE STUDIES.

WHEREAS, on November 17, 2015, the San Diego City Council (City Council) approved a five-year rate increase for potable water from FY 2016-FY 2020 and an increase in the recycled water rate, which was a result of the cost of service study (COSS) completed in 2015 for the San Diego Public Utilities Department (Department); and

WHEREAS, the Department, via the San Diego Purchasing and Contracting Department, solicited a Request for Proposals for a not-to-exceed five-year agreement to aid the Department with financial expertise relating to cost of service and financial analysis for Water, Wastewater and Recycled Water services, and Raftelis Financial Consultants, Inc. (RFC) was determined by to be the most responsive bidder; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to execute an agreement with Raftelis Financial Consultants, Inc. (RFC) on file with the City Clerk as RR- 31176 (Agreement) to provide As-Needed Financial Consultant Services in an amount not to exceed \$981,382, with a contract duration of five years; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$981,382 in total from Municipal Sewer Revenue Fund (700000), Metropolitan Sewer Utility Fund (700001), and Water Utility Operating Fund (700011) over five years for the purpose of funding the As-Needed Financial Consultant Agreement with RFC,

contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the San Diego City Treasurer.
