A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A FIFTH AMENDMENT TO THE AGREEMENT WITH IMS RECYCLING SERVICES AND ALLAN COMPANY FOR PROCESSING, TRANSPORTING, AND MARKETING COMMINGLED CURBSIDE RECYCLABLES.

WHEREAS, the City requires the continued services of a contractor to process, transport, and market the recyclable materials collected in the City's curbside recycling program; and

WHEREAS, in October 1998, after completion of a competitive request for proposal process, the Council authorized a revenue-generating agreement with IMS Recycling Services and Allan Company to process, transport, and market the recyclables collected by the City in its curbside recycling program (Agreement); and

WHEREAS, pursuant to the Agreement, the Council authorized four subsequent amendments to modify and extend the Agreement; and

WHEREAS, during the adoption process for the City's Zero Waste Plan, the Environmental Services Department (ESD) committed to studying whether to add expanded polystyrene (EPS) food service containers to the City's curbside recycling program, and ESD subsequently determined that EPS could be added as a new recyclable material type; and

WHEREAS, ESD negotiated a fifth amendment to the Agreement with IMS Recycling Services and Allan Company that obligates the contractors to process, transport, and market EPS as a recyclable material collected in the City's curbside recycling program, beginning July 1, 2017; and

WHEREAS, on May 25, 2017, the Environment Committee unanimously recommended approval of this item; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, a fifth amendment to the Agreement with IMS Recycling Services and Allan Company to process, transport, and market recyclable materials collected in the City's curbside recycling program, under the terms and conditions set forth in the Fifth Amendment, on file in the Office of the City Clerk as Document No. RR- 311187
