A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN JACALYN LAYWER, GUY LAWYER, CATHY LAWYER AND THE CITY OF SAN DIEGO

WHEREAS, on March 11, 2016, JACALYN LAYWER, GUY LAWYER and CATHY LAWYER filed a claim against the City of San Diego [City] alleging property damage arising from a failure of a City-owned 36-inch corrugated metal storm drain, inundating the surrounding property with water and sediment; and

WHEREAS, in Closed Session on May 23, 2017, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and absent, All Present, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council:

- 1. Authorizing the Mayor or his designee to pay the total sum of \$400,000.00 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the property and personal injury damage claim of Jacalyn Lawyer, Guy Lawyer and Cathy Lawyer. The City has advanced \$50,000.00 to Claimants.
- 2. Authorizing the Chief Financial Officer to appropriate and expend the total sum of \$350,000.00 from the Public Liability Fund No. 720045, contingent upon the Chief Financial

Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizing the Comptroller to issue a check for the outstanding balance of Three Hundred Fifty Thousand dollars and zero cents (\$350,000.00), made payable to "TBM Client Trust Account RE: Lawyer."
