WHEREAS, the City seeks to participate in the Beacon Program sponsored by the Institute for Local Government and the Statewide Energy Efficiency Collaborative; and

WHEREAS, the Beacon Program recognizes and celebrates California cities that voluntarily save energy, conserve resources, promote sustainability, and reduce greenhouse gas emissions; and


WHEREAS, the City's participation in the Beacon Program will highlight the goals set forth in the City's Climate Action Plan adopted in 2015; and

WHEREAS, the City will be recognized with silver, gold, and platinum Beacon Program award designations for undertaking sustainability activities in ten areas that include: energy efficiency and conservation; water and wastewater systems; green building; waste reduction and recycling; climate-friendly purchasing; renewable energy and low carbon fuels; efficient transportation; land use and community design; office space and offsetting carbon emission; and promoting community and individual action; and

WHEREAS, the City's participation in the Beacon Program is voluntary and does not include an association fee; and

WHEREAS, in order to participate in the Beacon Program, the City must submit an application and adopt a resolution by its governing body; NOW, THEREFORE,



