A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING APPOINTMENTS AND REAPPOINTMENTS TO THE CITIZENS EQUAL OPPORTUNITY COMMISSION

WHEREAS, the San Diego City Council ("Council") adopted an ordinance, codified at San Diego Municipal Code section 26.16, establishing the Citizens Equal Opportunity Commission; and

WHEREAS, section 26.16 provides that the Commission monitor and/or evaluate the City's Equal Opportunity Program; advise the Mayor, Council, Civil Service Commission and other appropriate agencies; submit written quarterly reports for review by the Council's Committee on Budget and Government Efficiency and the Council; assist in recruiting competent minorities, women, and disabled persons to compete for available City positions; and promote the City of San Diego as an Equal Opportunity Employer of individuals and firms desiring to contract with the City; and

WHEREAS, the ordinance provides that the Commission shall consist of 11 members appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the ordinance provides that the Commission shall include nine representatives who actively advocate for or represent each of the following groups: Latino, African-American, Filipino, Native American, Asian/Pacific Islander, Disabled, Lesbian/Gay/Bisexual/Transgender (LGBT), Women, and Disabled Veterans; and

WHEREAS, the designated positions of Women's Advocate and Disabled Veterans'
Advocate were recently added to the Commission and the Mayor seeks to make initial
appointments to those positions; and

WHEREAS, the ordinance provides that members shall serve two-year terms; each member shall serve until a successor is duly appointed and confirmed; and all terms must have expiration dates of January 1; and

WHEREAS, the Mayor now seeks confirmation of appointments and reappointments to the Commission; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments and reappointments by the Mayor of the City of San Diego, to serve as members of the Citizens Equal Opportunity Commission, for terms expiring as indicated, are made and hereby confirmed:
