A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING AN AGREEMENT WITH THE
CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY
SERVICES TO REIMBURSE THE FIRE-RESCUE
DEPARTMENT FOR TRAINING COSTS ASSOCIATED WITH
THE HAZARDOUS MATERIALS BY RAIL PROGRAM.


WHEREAS, the California Governor's Office of Emergency Services has offered to
reimburse the City for costs of Hazardous Materials by Rail Program training for Fire-Rescue
Department employees; and

WHEREAS, the City's General Fund will be reimbursed by an amount not to exceed
\$179,147.74; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his
designee is authorized to execute a one-year agreement between the City of San Diego Fire-
Rescue Department and the California Governor's Office of Emergency Services to reimburse
the Fire-Rescue Department for costs associated with training related to the Hazardous Materials
by Rail Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$179,147.74 through June 30, 2018 contingent upon the adoption of the Fiscal Year 2018 Appropriation Ordinance, and contingent upon the Chief Financial Officer furnishing a certificate certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

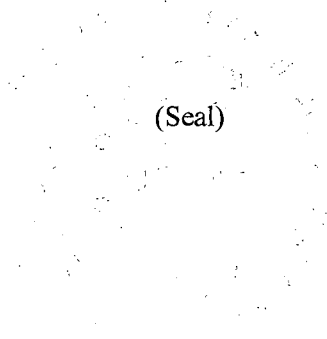
