A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING COUNCIL POLICY NO. 600-27
REGARDING AFFORDABLE/IN-FILL HOUSING AND
SUSTAINABLE BUILDINGS EXPEDITE PROGRAM.

WHEREAS, the City Council is considering the adoption of amendments to the San Diego Municipal Code to create processes and regulations regarding affordable housing, in-fill development, and sustainable projects; and

WHEREAS, the current Council Policy 600-27 contains processes and regulations that are more appropriately contained in the proposed San Diego Municipal Code amendments; and

WHEREAS, Council Policy 600-27 is proposed to be amended to remove the regulatory provisions that are contained in the proposed San Diego Municipal Code amendments; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that Council Policy No. 600-27 titled "Affordable/In-Fill Housing and Sustainable Buildings Expedite Program" is amended as set forth in the Council Policy on file in the office of the City Clerk as Document No. RR- 311256.

BE IT FURTHER RESOLVED, that this resolution shall be effective when Ordinance No. O- 20856, amending the San Diego Municipal Code to create regulations regarding affordable housing, in-fill development, and sustainable projects take effect.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to add the aforesaid to the Council Policy Manual.

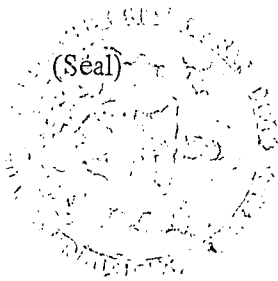
