A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO VACATING A PORTION OF NATIONAL AVENUE, 43RD STREET, LOGAN AVENUE, AND SAN PASQUAL STREET WITH VACATION NUMBERS 1894384, 1963838, 1963820, 1963771, 1963823, AND 1963805 AS PART OF THE 43RD STREET VACATIONS PROJECT – PROJECT NO. 497069.

WHEREAS, California Streets and Highways Code section 8320 *et seq.* and San Diego Municipal Code section 125.0901 *et seq.* provide a procedure for the vacation of public rights-of-way by City Council resolution; and

WHEREAS, Public Works Department filed an application to vacate portions of the public right-of-way along National Avenue, 43rd Street, Logan Avenue, and San Pasqual Street within the Southeastern San Diego Community Planning, being described as Right-of-Way Vacation Nos. 1894384, 1963838, 1963820, 1963771, 1963823, and 1963805; and

WHEREAS, Right-of-Way Vacation Nos.1894384, 1963838, 1963820, 1963771, 1963823, and 1963805 is located on property owned by the landowners of APN Nos. 551-630-0400, 551-080-3200, 551-080-3300, 551-630-0400, 551-060-1200, 551-060-0402, 551-060-0401, 551-060-0600, 551-060-0500, 551-060-0700; and

WHEREAS, under Charter Section 280(a)(2), this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body, a public hearing was required by law implicating due process rights of individuals affected by the decision, and the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; and

WHEREAS, the matter was set for public hearing on July 25, 2017, testimony having been heard, evidence having been submitted, and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that with respect to Right-of-Way Vacation Nos. 1894384, 1963838, 1963820, 1963771, 1963823, and 1963805, the Council makes the following findings required by San Diego Municipal Code section 125.0941:

(a) There is no present or prospective public use for the public right-of-way, either for the facility for which it was originally acquired or for any other public use of a like nature that can be anticipated.

The proposed vacations for portions of public right-of-way along National Avenue, 43rd Street, Logan Avenue, and San Pasqual Street are necessary to record the mapping actions necessary to reflect the completed roadway project at the intersection of 43rd Street, Logan Avenue, and National Avenue. The existing public right-of-way that is no longer needed was originally configured as two non-standard, discontinuous intersections. In order to improve traffic flow and pedestrian access along this corridor, the intersection of these collector streets were realigned and thus portions of the public right-of-way are no longer required for street purposes. The new alignment of National Avenue, 43rd Street, Logan Avenue, and San Pasqual Street have been constructed to its ultimate width at this intersection and are consistent with the Southeastern San Diego Community Plan. Therefore, there is no present or prospective public use for these portions of public right-of-way, or for any other public use of a like nature that can be anticipated.

(b) The public will benefit from the action through improved use of the land made available by the vacation.

The proposed vacations of portions of public right-of-way along National Avenue, 43rd Street, Logan Avenue, and San Pasqual Street are necessary to records the mapping actions necessary to reflect the completed roadway project at the intersection of 43rd Street, Logan Avenue, and San Pasqual Street, originally configured as a non-standard, discontinuous intersection. The vacation will benefit the public by conveying property rights to the abutting private landowners (APN Nos. 551-630-0400, 551-080-3200, 551-080-3300, 551-630-0400, 551-060-1200, 551-060-0402, 551-060-0401, 551-060-0600, 551-060-0500, 551-060-0700) and amending the lot lines of these abutting properties. The portions of right-of-way proposed to be vacated are to be used for the benefit of the adjacent landowners and its patrons, for uses such as parking lot, landscaping and green areas, and residential yards.

Therefore, the public will benefit from the action through improved use of the land made available by the vacation.

(c) The vacation does not adversely affect any applicable land use plan.

The proposed partial public right-of-way vacations along National Avenue, 43rd Street, Logan Avenue, and San Pasqual Street are necessary to record the mapping actions necessary to reflect the completed roadway project at the intersection of 43rd Street, Logan Avenue, and San Pasqual Street originally configured as a non-standard, discontinuous intersection. The proposed project will have no adverse effect on the adopted General Plan and Southeastern San Diego Community Plan as this excess right-of-way is a result of the realignment of the intersection, which intended to provide an improved high quality facility that benefits all users. Therefore, the vacation does not adversely affect any applicable land use plan.

(d) The public facility for which the public right-of-way was originally acquired will not be detrimentally affected by the vacation.

The proposed partial public right-of-way vacations along National Avenue, 43rd Street, Logan Avenue, and San Pasqual Street are necessary to record the mapping actions necessary to reflect the completed roadway project at the intersection of 43rd Street, Logan Avenue, and San Pasqual Street originally configured as a non-standard, discontinuous intersection. The proposed project will not detrimentally affect the City's public rights and facilities within the existing right-of-way. Public facilities were relocated as needed during the realignment of the intersection to be within the current public right-of-way, and continues to serve the public in the same manner as originally intended. Therefore, the public facility for which the public right-of-way was originally acquired will not be detrimentally affected by these vacations.

BE IT FURTHER RESOLVED, that Right-of-Way Vacation Nos. 1894384, 1963838, 1963820, 1963771, 1963823, and 1963805, as more particularly described in the legal description marked as Exhibit "A" and shown on Drawing Nos: 38547-B, 38548-B, 38549-B, 38550-B, and 39064-B, marked as Exhibit "B," which are by this reference incorporated herein and made a part hereof, is ordered vacated.

BE IT FURTHER RESOLVED that the Development Services Department shall record a certified copy of this resolution with attached exhibits, attested by the City Clerk under seal, in the Office of the County Recorder.

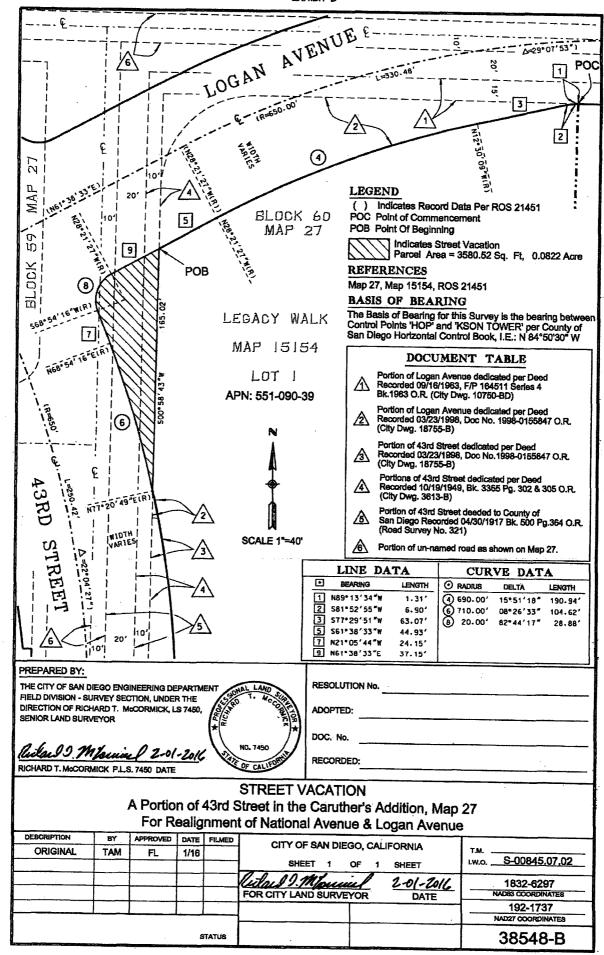
