A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AWARD AND EXECUTION OF THE CONSULTANT AGREEMENT WITH RICK ENGINEERING TO PROVIDE PROFESSIONAL SERVICES FOR VARIOUS CAPITAL IMPROVEMENTS PROGRAM PROJECTS CITYWIDE; AND TAKING RELATED ACTIONS.

WHEREAS, this action will execute and award an agreement to Rick Engineering to provide as-needed civil engineering services on an as-needed, hourly fee basis in support of the timely execution of the City of San Diego's (City) Capital Improvements Program (CIP) projects citywide for a total amount not to exceed \$4,000,000 with a maximum duration of five years; NOW, THEREFORE,

- 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an agreement with Rick Engineering to provide as-needed civil engineering services for the timely execution of various Capital Improvements Program projects citywide in an amount not to exceed \$4,000,000 with a maximum duration of five years, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. RR-311272
- 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$4,000,000 over five years for the purpose of funding the As-Needed Civil Engineering Services Agreement with Rick Engineering, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.

- 3. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 from Fund 720057, Engineering & Capital Projects, for the purpose of executing this agreement and meeting minimum contract requirements.
- 4. That the Chief Financial Officer is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
