A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT AUTHORIZATION OF THE FOURTH AMENDMENT TO THE SUB-GRANTEE AGREEMENT WITH THE COUNTY OF SAN DIEGO FOR GRANT FUNDING FOR LEAD ENFORCEMENT ACTIVITIES IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTIONS 15301 AND 15321.

WHEREAS, the City is eligible for grant funding from the California Department of Public Health (CDPH) for programs to eliminate lead hazards and to assist other local agencies with lead enforcement; and

WHEREAS, as a requirement of the grant, the City must contract as a sub-grantee of the County of San Diego; and

WHEREAS, the City and the County of San Diego desire to extend their current subgrantee contract through June 30, 2018, so that the City may continue to receive CDPH grant funding for code enforcement activities that protect children from lead poisoning (Project); and

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, Section 15000 et seq.) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of Projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Development Services Department has established that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines sections 15301 and 15321, and that no exception to the exemption, as set forth in CEQA Guidelines section 15300.2, applies to the Project; and

WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of the Project, and

WHEREAS, the City Council held a duly noticed public meeting and considered the written record for the Project as well as public comment; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has determined that the Project will not have a significant effect on the environment as the Project's potential implementation of various health-related modifications to existing structures would constitute minor alteration of existing structures and would involve negligible or no expansion of use, and the Project's potential enforcement actions would constitute enforcement of a law, general rule, standard, or objective, administered or adopted by the City; NOW THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego determines that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines sections 15301 and 15321.

BE IT FURTHER RESOLVED, that the Council of the City of San Diego has determined that an exception to the exemption as set forth in CEQA Guidelines section 15300.2 does not apply.
