A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT
BETWEEN MICHAEL SHERMAN AND THE CITY OF
SAN DIEGO RELATED TO 4018-4024 HAMILTON
STREET, SAN DIEGO, CALIFORNIA

WHEREAS, Michael Sherman filed a claim with the City of San Diego (City) for damages to his residence and property located at 4018-4024 Hamilton, San Diego, California, following the failure of a City storm drain on January 5, 2017. Claim No. 14713 was reviewed by City of San Diego's Risk Management Department; and


WHEREAS, on June 13, 2017, the City Council by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7 8, 9; Nays, None; and Absent, None, approved the settlement of the claim for an amount consistent with the amounts set forth below; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

1. Authorizing the Mayor or his designee to pay the sum of \$53,160.08 from the Liability Fund 700011 in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the January 5, 2017 incident that is the subject of Michael Sherman's claim;
2. Authorizing the Chief Financial Officer to appropriate and expend \$53,160.08 from the Liability Fund 700011, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and

3. Authorizing the Comptroller to issue a check for the outstanding balance of Fifty Three Thousand One Hundred Sixty Dollars and Eight cents (\$53,160.08) made payable to Michael Sherman.
