A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A GRANT HOST AGREEMENT BETWEEN CENTER FOR SUSTAINABILE ENERGY AND CITY OF SAN DIEGO FOR BRANCH LIBRARIES DEMONSTRATION PROJECT

WHEREAS, the City of San Diego ("City") has adopted a Climate Action Plan and it is in the City's interest to demonstrate viability of making municipal buildings as energy efficient and energy independent as possible; and

WHEREAS, the not-for-profit Center for Sustainable Energy (CSE) has applied for and obtained from the California Energy Commission ("CEC") a Grant No. EPC-15-085 ("Grant") in the amount of \$3,259,084, to fund innovative, cost effective energy efficiency technologies and to install energy storage and solar photovoltaic (PV) systems that, when combined, result in Integrated Demand Side Management (IDSM) and Zero Net Energy (ZNE) demonstrations in three City branch libraries; and

WHEREAS, the City has represented to CSE and to the CEC that it is pleased to host the IDSM/ZNE Grant demonstration project at the Point Loma, Malcolm X, and Serra Mesa – Kearny Mesa branch libraries; and

WHEREAS, the City has further represented to the CEC that it will match the Grant funds with a host match of services valued at \$482,000, consisting of solar energy purchases from PV systems already under contract with a third party, in-kind labor, and library funds; and

WHEREAS, the City and CSE intend to provide terms in a Grant Host Agreement for the execution of the work necessary to fulfill the Grant conditions;

WHEREAS, the City and CSE, through the Grant Host Agreement, intend to jointly contract with McBreaty Construction Corporation, as identified in the Grant, for the construction elements of the Grant work in the City buildings, and intend that CSE will be responsible for all work and payments;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that:

- 1. The Mayor or his designee is hereby authorized to execute a Grant Host Agreement with the Center for Sustainable Energy to effectuate ZNE demonstration projects under California Energy Commission (CEC) Grant No. EPC 15-085 at the Point Loma, Malcolm X, and Serra Mesa-Kearny Mesa branch libraries under the terms and conditions of the document on file in the Office of the City Clerk as Document No. \$\frac{11289}{311289}\$, and
- 2. The Chief Financial Officer is authorized to expend an amount of \$482,000 for City match funding for CEC Grant No.15-085, consisting of the following elements: Solar photovoltaic electricity provided and purchased during Grant term in the amount of \$220,000 expended from Library Department, General Fund No. 100000; in-kind City labor in the amount of \$180,000 from Energy Conservation Program Fund No. 200224; and the purchase of furnishings, fixtures, and equipment in the amount of \$82,000 from Library Improvement Trust Fund. No. 200369, contingent upon the Chief Financial Officer certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 3. Authorizing the Mayor or designee to execute, jointly as a co-party with the Center for Sustainable Energy, a construction agreement with McBreaty Construction

  Corporation for the construction elements of the work necessary to fulfill the requirements of

CEC Grant No. 15-085, provided that the terms of the construction contract are consistent with the terms of the Grant Host Agreement, and provided that all required environmental determinations are complete and satisfied.
