A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE APPROVAL OF THE AMENDMENTS TO THE SAN DIEGO MUNICIPAL CODE ALLOWING MARIJUANA PRODUCTION FACILITIES IS STATUTORILY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT, PURSUANT TO CALIFORNIA BUSINESS AND PROFESSIONS CODE SECTION 26055(h).

WHEREAS, the City desires to amend the San Diego Municipal Code to allow marijuana production facilities for the agricultural raising, harvesting and processing of marijuana; the wholesale distribution and storage of marijuana and marijuana products; and the production of goods from marijuana and marijuana products (Project); and

WHEREAS, marijuana production facilities would only be allowed pursuant to a Conditional Use Permit, a discretionary development permit subject to review under the California Environmental Act (CEQA), Public Resources Code sections 21100-21177; and

WHEREAS, the California State Legislature, through Business and Professions Code section 26055(h), has determined that CEQA does not apply to the adoption of an ordinance, rule, or regulation by a local jurisdiction that requires discretionary review and approval to engage in commercial cannabis activity; and

WHEREAS, the Planning Department has established that the portion of the Project regarding the future permitting of marijuana production facilities is statutorily exempt from CEQA pursuant to California Business and Professions Code section 26055(h); and

WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of the Project, and

WHEREAS, on September 11, 2017, the City Council held a duly noticed public meeting and considered the written record for the Project as well as any public comment; and

WHEREAS, the Council of the City of San Diego, using its independent judgment determined that the Project will not have a significant effect on the environment; NOW, THEREFORE,

BE IT RESOLVED, that the Project is statutorily exempt from CEQA pursuant to California Business and Professions Code section 26055(h).
