A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS TO THE
CIVIL SERVICE COMMISSION

WHEREAS, the City of San Diego’s Civil Service Commission (Commission) is established in section 41(b) of the San Diego Charter; and

WHEREAS, the Commission has supervision over the selection, promotion, and removal of all employees of the City of San Diego (City), subject to the Civil Service provisions of the Charter, as stated in Charter section 115; and

WHEREAS, the Commission is to be composed of five members who are electors of the City; and

WHEREAS, members are to serve five-year terms and until a successor is appointed and qualified, and are to be appointed so that no more than one individual’s term shall expire in a given year; and


WHEREAS, the Mayor shall appoint Commission members, subject to confirmation by the Council; and

WHEREAS, members shall not hold any other office in City government; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments by the Mayor of the City of San Diego, to serve as members of the City of San Diego’s Civil Service Commission, for terms ending as indicated, are made and hereby confirmed:


